



Data Insight



We reviewed consumption behavior of various cohorts of cannabis consumers on WM over time and found that their demand for cannabis is inelastic — which means that overall demand (at the industry level) is relatively insensitive to price changes.


For example - we found that a one dollar decrease in average price per item would result in only a 20-50 cent decrease in average order value depending on the region and customer segment. Similarly, we would not expect increasing prices to drive large decreases in overall demand. In short, **our internal data review supports our belief that while cannabis users are always looking for value, overall demand is relatively insensitive to price.**

Weedmaps' immersive art installation, "Flowers are not a Crime," had its East Coast debut at **The Governors Ball** in New York City, June 10 - 12.



State Updates:

New York: New York's Office of Cannabis Management released draft regulations for advertising, marketing, and labeling of legal cannabis products. The state also continued issuing conditional cultivation licenses, with 41 additional approvals in June.

Illinois: Governor J.B. Pritzker signed a bill into law that removes a positive cannabis test as a justifiable reason to deny an individual's criminal record expungement or record sealing. Also, after the resolution of years-long litigation the State is working to process up to 185 new dispensary licenses and over 60 craft grow licenses.

Indiana: The legislature stood-up a summer committee to study the benefits of cannabis as well as decriminalization of cannabis possession.

Nebraska: Activists continue to gather signatures for a medical cannabis legalization ballot measure, with a deadline looming on July 7. Signature gathering efforts were recently buoyed when a federal judge issued a preliminary injunction which blocked the state from requiring that organizers collect signatures of 5% of registered voters in each county.

Kansas: The state Legislature approved the creation of a Special Committee on Medical Marijuana that will begin to develop cannabis reform legislation prior to the 2023 legislative cycle.

North Carolina: After passing the state Senate with significant support, the North Carolina House of Representatives blocked a medical cannabis legalization bill from advancing further.

Delaware: The state House of Representatives failed to override Governor Carney's veto of an adult-use cannabis legalization measure.

Pennsylvania: A bill to rebuff IRS Code 280E passed the state's House Finance Committee. If approved, the legislation would allow medical cannabis businesses in Pennsylvania to receive state tax deductions for expenses that are otherwise prohibited by the IRS.

Michigan: The state's first open-to-the-public cannabis consumption lounge, Kalkushka Lounge, opened on June 1. This is the second establishment to be awarded a consumption lounge license in Michigan. Also, the city of Grand Haven voted to opt-in to allowing cannabis establishments to operate in the jurisdiction and the City of Detroit issued its first adult-use license.

Maine: The Maine Office of Cannabis Policy released a report detailing the continued success of the state's adult-use cannabis market. Of note, the report describes the state's regulated market as comprising 64% of the cannabis market - strongly overtaking the unregulated market.

Louisiana: Governor John Bel Edwards signed a bill offering new employment protections for state employees registered as medical

cannabis patients. This bill was approved among other cannabis-related measures, one of which allows for more medical cannabis dispensaries to operate in the state and another that allows for reciprocity with other states' medical programs.

Mississippi: Over 1,800 applications have been received since the opening of the application window for individual, services, and facilities licenses. The dispensary application window is set to open at the beginning of July.



Five Cannabis Legalization "Hot Spots" Around The World

The United States isn't the only place where cannabis legalization is moving forward and gaining momentum. Legalization is a global issue and a top priority in many countries. Here are snapshots of five current cannabis legalization "hot spots" around the world that our international policy team have their eyes on:

Germany intended to legalize adult-use sales by the end of the current legislative period. But the Covid-19 pandemic and the war in Ukraine are priorities. Pundits are optimistic that a draft bill could be released before the

end of the year.

Advocates in **Italy** have seen several legalization attempts fail in recent years. They had hoped to use a nationwide ballot initiative to decriminalize personal cultivation of cannabis and eliminate penalties for possession. But Italy's high court ruled that the national referendum process could not be used.

Switzerland announced plans to legalize cannabis cultivation, trade, and consumption in October 2021, leaving the National Council to develop a framework for an integrated medical/adult-use program. In the meantime, Zurich, Switzerland's largest city, will host a three-year pilot project to study the social effects of adult-use cannabis on Swiss society.

Last year at this time, **Mexico** was on the verge of passing comprehensive cannabis legalization. But to the world's surprise, the bill failed. Further rulings from the high court last June paved the way for local government permits allowing Mexicans to possess, cultivate, and use cannabis, as country-wide legalization no longer seems to be a priority.

June 9 marks a big day for **Thailand**, as decriminalization takes effect, and people are allowed to cultivate any amount of cannabis for personal use. Thailand's FDA leader continues to speak about the possibility of adult-use legalization, but for now, Thai officials anticipate a gradual ease in restrictions as the new industry takes hold.
